## January 9, 2020

## 1. Call to Order, Roll Call, and Quorum Determination

TPC Chair Judge Krebs called the meeting to order at 2:03 p.m. at the City of Corpus Christi Council Chambers.

## 2. Election of Officers for the Transportation Policy Committee

In accordance with the MPO Bylaws, the Transportation Policy Committee shall elect a Chairperson and a Vice Chairperson from among its voting members during the first meeting of each calendar year.

Mr. Zahn motioned to re-elect Judge Krebs for Chairperson, Mayor Skurow seconded. Mayor Skurow motioned to re-elect Mr. Zahn for Vice Chairperson, Judge Krebs seconded. Both motions passed unanimously.

#### 3. Public Comments for items not on the Agenda

Judge Krebs called for public comments for items not on the agenda. None offered.

### 4. Approval of the December 5, 2019 TPC Regular Meeting Minutes

Mr. Zahn made a motion to approve the December 5, 2019 TPC Meeting Minutes. Judge Canales seconded; motion passed unanimously.

## 5. Discussion and Possible Action: DRAFT 2020-2045 Metropolitan Transportation Plan (MTP)

### A. DRAFT 2020-2045 MTP

Mr. MacDonald reported that all fourteen draft chapters of the 2020-2045 MTP are ready for release to request final public comments. Each draft chapter was released for review and comment as it was developed, and additional draft chapters were completed. There is one substantial change in Chapter 7: Implementation Plan due to the additional projects submitted by the Corpus Christi Regional Transportation Authority (CCRTA). Upon TPC's approval, all draft chapters will become available for public review; comments are accepted until February 6, 2020.

Mr. MacDonald told the TPC that the Executive Summary is under development and will be ready for the January 14, 2020 Public Meeting/Open House and the January 16, 2020 Technical Advisory Committee (TAC) meeting. The Executive Summary is not new material, but a collection of important elements from the 14 chapters.

Mayor McComb inquired if the public comment period is less than 30 days. Mr. MacDonald explained that the comment period is a month, between January TPC and February TPC meeting, and it satisfies federal requirements.

Mayor Skurow inquired about the deadline for public comments. Mr. MacDonald explained that the February 6, 2020 TPC meeting is the final public hearing opportunity and February 6, 2020 is the cutoff date for the public comments before the TPC's official adoption of the 2020-2045 MTP. Comments collected during the February 6, 2020 TPC meeting will be reflected in the 2020-2045 MTP. Mayor Skurow asked if the TPC is required to table the adoption of 2020-2045 MTP due to the public comments. Mr. MacDonald answered that the TPC is allowed to adopt the 2020-2045 MTP by approving "subject to public comments" unless the public comments require a substantial change in the 2020-2045 MTP. The 2015-2040 MTP has been expired and currently no long-range transportation plan is in place. The adoption of 2020-2045 is an urgent necessity to keep transportation projects moving forward in this region.

Judge Canales made a motion to approve the release of the DRAFT 2020-2045 MTP to the public for review and comment. Mayor Skurow seconded; motion passed unanimously.

## B. DRAFT 2020-2045 MTP Appendices

Mr. MacDonald explained most of the appendices are relevant documents published by partner agencies and entities to support the chapter contents. Appendix B: Public Comments and Appendix C: Public Notices are still under development. Public Comments opportunities are given until February 6, 2020 and all comments submitted by and on February 6, 2020 will be included in Appendix B: Public Comments. The MPO issued a Public Notice on Caller-Times for the final Public Meeting/Open House event on January 5, 2020 and the proof will be included in Appendix C: Public Notices.

Mayor Skurow inquired if the 2020-2045 MTP Chapters and Appendices are one document or separated. Mr. MacDonald showed the MPO website that each chapter of 2020-2045 MTP and each appendix of 2020-2045 MTP are independently presented.

Mr. Zahn made a motion to approve the release of DRAFT 2020-2045 MTP Appendices to the public for review and comment. Judge Canales seconded; motion passed unanimously.

## C. Public Comment Opportunity for DRAFT 2020-2045 MTP

This is a public comment opportunity for the 2020-2045 MTP Chapters and Appendices already available to the public for review and comment.

Mayor Skurow inquired which chapters have been already released to the public. Currently Chapter 1: Introduction, Chapter 2: Planning Requirements Agency Coordination and Public Outreach, Chapter 3: Planning Framework, Chapter 4: Demographics and Forecasting, Chapter 6: Financial Plan, Chapter 7: Implementation Plan, and Chapter 14: Air Quality Analysis completed the public comment period and were approved by the TPC. Chapter 12: Strategic Plan for Active Mobility Phase 1: Bicycle Mobility Plan was released for the public on December 5, 2019 and completed its public comment period.

Judge Krebs called for public comments. None offered.

## D. DRAFT Congestion Management Process (CMP)

Mr. MacDonald explained that the CMP is one of the federally required elements in a long-range transportation plan to address congestion. As reported before, the MPO is required to submit a revised CMP by the end of November due to the 2017 Federal Certification Review. The DRAFT CMP was submitted to the Federal Highway Administration (FHWA) on November 29, 2019.

Mr. MacDonald requested the TPC release the DRAFT CMP to the public for review and comments.

Judge Canales made a motion to approve the release the DRAFT CMP for public comments. Mayor Skurow seconded: motion passed unanimously.

Judge Canales suggested sending the DRAFT 2020-2045 MTP and the DRAFT CMP to the legislature/delegation and hold a meeting with them for comments, as it is difficult to reach out for

comments. Mr. MacDonald answered that the MPO sent the information and available links to the agencies, entities, and stakeholders listed in Chapter 2, and will follow up with them.

Mr. MacDonald confirmed (1) the final Public Meeting/Open House event will be held on January 14, 2020 at CCRTA Staples Center starting at 4:30 p.m., (2) two public hearing opportunities are given on January 16, 2020 at the TAC meeting, and February 6, 2020 at the TPC meeting, and if the TPC approves the DRAFT 2020-2045 MTP on February 6, 2020, it will be the official adoption of 2020-2045 MTP and it will be submitted to FHWA.

Judge Krebs stated that the TPC members have been pleased by the Mr. MacDonald's excellent job as the MPO Director, and they will hold another evaluation on the one-year anniversary. No action is proposed for this item based on the discussions within the executive session.

## Summary

## Summary

Over the last eight months, the Corpus Christi MPO staff developed the DRAFT 2020-2045 MTP and DRAFT CMP for review by the Technical Advisory Committee (TAC), Transportation Policy Committee (TPC), our partner federal, state and local agencies and the public. We have provided the public a complete set of the DRAFT 2020-2045 MTP and the DRAFT CMP for their review and comment prior to the final action by the TPC at their Regular Meeting on February 6, 2020.

The information in the DRAFT 2020-2045 MTP and the DRAFT CMP is the collection of the required data and analysis in accord with the federal planning laws and regulations. This information is a collection of existing information that was available on the TxDOT and local governments websites and has been collected and organized into the MPO long-range planning document (DRAFT 2020-2045 MTP). We believe that the information is only being reorganized and analyzed from information already in the public domain, not new calculations, policy or information related to our regional transportation plan.

The TPC is being asked to review and discuss the DRAFT 2020-2045 MTP and the DRAFT CMP and approve the two documents by Resolution (See Attachment). The documents are available on the Corpus Christi MPO website at the following link HERE.

## **RESOLUTION 20-01**

Approving the 2020-2045 Metropolitan Transportation Plan (MTP) and the Congestion Management Process (CMP) for the Corpus Christi Metropolitan Area

WHEREAS, the Corpus Christi Metropolitan Planning Organization (MPO) is the designated MPO for the Corpus Christi Metropolitan Area with responsibilities to perform regional transportation planning and programming, in cooperation with the Texas Department of Transportation (TxDOT) and the Corpus Christi Regional Transportation Authority (CCRTA), the major transit operator; and

WHEREAS, Corpus Christi Urbanized Area has a population greater than 200,000 and has, therefore, been designated as a Transportation Management Area (TMA), and is therefore subject to special planning programming requirements regarding congestion management systems, project selection, certification; and

WHEREAS, one of the primary responsibilities of the Corpus Christi MPO is to prepare and approve a long-range regional transportation plan in accordance with the Fixing America's Surface Transportation (FAST) Act (23 U.S.C. 104, 134) and implementing U.S. Department of Transportation (DOT) regulations (23 C.F.R. 450); and

WHEREAS, the regional transportation plan is a multi-modal transportation systems plan that defines the goals for the region and specifies the policies, projects, and strategies to help achieve these goals, and also ties the goals to performance measures to be used to track the region's progress in meeting plan goals over time; and

WHEREAS, in preparing the 2020-2045 MTP, the Corpus Christi MPO followed federal guidance as set out in the Metropolitan Transportation Planning rule, 23 C.F.R. 450, including consideration of the federal planning factors, identification of performance measures, and preparation of financial, environmental, and environmental justice analyses of the plan and also utilized an extensive public involvement process; and

WHEREAS, the regional transportation plan is intended to guide implementing agencies in development of projects and implementation of other recommendation and supporting actions to guide improvements for all modes of transportation; and

WHEREAS, the Texas Transportation Commission uses the Unified Transportation Program (UTP) as a 10-year guide for transportation project development within their 24-year Statewide Long-Range Transportation Plan (SLRTP) for statewide projects, and the 2020 – 2029 UTP was adopted in August 29, 2019; and

**WHEREAS**, the MPO is required to provide a Congestion Management Process (CMP) to address regulations set forth in 23 C.F.R. 450.322 and 23 C.F.R. 500.109; and

**NOW, THEREFORE, BE IT HEREBY RESOLVED,** The Transportation Policy Committee (TPC) of the Corpus Christi MPO approves the 2020-2045 Metropolitan Transportation Plan (MTP) for the Corpus Christi Area effective February 6, 2020;

**BE IT FURTHER RESOLVED** that the Transportation Policy Committee (TPC) of the Corpus Christi MPO approves the Congestion Management Process (CMP) for the Corpus Christi Area effective February 6, 2020;

**BE IT FURTHER RESOLVED** that the Transportation Policy Committee (TPC) certifies the plan meets the financial constraint requirements for long-range regional transportation plans;

**BE IT FURTHER RESOLVED** that the Transportation Policy Committee (TPC) certifies that the federal metropolitan transportation planning process is addressing major issues facing the metropolitan area and is being conducted in accordance with all applicable federal requirements, including:

- 1. 23 U.S.C. 134 and 49 U.S.C. 5303, and this subpart;
- 2. Title VI of the Civil Rights Act of 1964, as amended (42 U.S.C. 200d-1) and 49 C.F.R. Part 21;
- 3. 49 U.S.C. 5332, prohibiting discrimination on the basis of race, color, creed, national origin, sex, or age in employment or business opportunity;
- 4. Sections 1101(b) of the FAST Act (Pub. L. 114-357) and 49 C.F.R. Part 26 regarding the involvement of disadvantaged business enterprises in U.S. DOT funded projects;
- 5. 23 C.F.R. Part 230, regarding the implementation of an equal employment opportunity program on Federal and Federal-aid highway construction contracts;
- 6. The provisions of the American with Disabilities Act of 1990 (42 U.S.C. 12101 et seq.) and 49 C.F.R. Parts 27, 37, and 38;
- 7. The Older Americans Act, as amended (42 U.S.C. 6101), prohibiting discrimination on the basis of age in programs or activities receiving Federal financial assistance;
- 8. 23 U.S.C. 324 regarding the prohibition of discrimination based on gender; and
- 9. Section 504 of the Rehabilitation Act of 1973 (29 U.S.C. 794) and 49 C.F.R. 27 regarding discrimination against individuals with disabilities.

### **Summary**

The Corpus Christi MPO staff is requesting the Transportation Policy Committee (TPC) consider the request from the partners of the San Patricio County Industrial Master Plan ("Participating Governments") to enable the Corpus Christi MPO staff to perform administrative functions related to the process. If approved by the TPC, the Participating Governments for the Industrial Master Plan (Plan) would work with the MPO staff to perform the following activities as specified in the Resolutions adopted by the Participating Governments (see Attachment):

That the Corpus Christi Metropolitan Planning Organization be approached to serve as an objective, third party administrator

- (a) to work with the County Commissioners Court and participating cities within San Patricio County (members of "Participating Governments") to select a qualified consultant,
- (b) to create the legal and operational framework for the Plan,
- (c) to aid Participating Governments by supervising the work of the qualified consultant, and
- (d) to provide other such guidance and oversight as may be needed to ensure the successful development of the Plan.

As the process continues, the MPO staff will provide updates to the TPC as necessary and request future actions if warranted.

## **Previous TPC Actions**

None, this is a new proposed activity for the MPO staff.

#### **Alternatives**

The TPC has the following alternatives to consider for this action item:

- Approve the current recommendation by the MPO staff
- Revise and approve a modified action based on the TPC members discussion
- Return the item to the MPO staff for further analysis and action

#### Recommendation

The MPO staff recommends that the TPC approve the MPO staff participation in the San Patricio County Industrial Master Plan process as determined by the Participating Governments. The MPO staff will

ensure that the San Patricio County Industrial Master Plan activities are administratively separate from the federally funded transportation planning program.

## **Proposed Motion**

Approve the MPO staff participation in the San Patricio County Industrial Master Plan process as documented in future agreements between the MPO and the Participating Governments.

#### **Financial Impact**

None at this time for the MPO. The funding for this project will be derived by the Participating Governments and agencies. The MPO is not being asked to be a financial partner, only an administrative partner. If there is a proposed change to this financial condition, the MPO staff will bring an item back to the TPC for consideration.

## **Background**

The Participating Governments of the proposed San Patricio County Industrial Master Plan have been discussing their process for several months. These efforts have led to the creation of resolutions for the Participating Governments. The resolutions that have been adopted are attached for reference. The following information was contained in the resolutions and is provided below as part of the background information for this topic.

Growth in the world petrochemical industry has shifted from the Middle East to the Texas Gulf Coast as production in North America continues to outpace other world markets with an expectation that such growth will continue and soon transform the Texas Gulf Coast into a world class center for petrochemical processing and exporting.   - b) Create the legal and operational framework for the Plan,
  - Aid Participating Governments by supervising the work of the qualified consultant, and
  - d) Provide other such guidance and oversight as may be needed to ensure the successful development of the Plan.

- That such qualified consultant shall work in collaboration with members of Participating Governments and all other contributing governmental bodies, communities, businesses and affected stakeholders in San Patricio County, Texas in the development of said Plan; and
- 4. That the cost of the Plan shall be shared between the members of Participating Governments in a fair and equitable manner.

#### **Summary**

Each metropolitan planning organization (MPO) is required, under 23 C.F.R. 450 326 and 49 U.S.C. 5303, to maintain a Transportation Improvement Program (TIP)—a list of funded transportation projects—covering a period of four years. The TIP must be developed in cooperation with the state department of transportation and local public transit providers. The TIP will include both capital and non-capital surface transportation projects, bicycle and pedestrian facilities and other transportation enhancements, Federal Lands Highway projects, and safety projects included in the State's Strategic Highway Safety Plan. The TIP will include all regionally significant projects receiving FHWA or FTA funds, or for which FHWA or FTA approval is required, in addition to non-federally funded projects that are consistent with the Metropolitan Transportation Plan (MTP). Furthermore, the TIP is fiscally constrained by year.

The TIP is prepared and adopted by the Corpus Christi Metropolitan Planning Organization (Corpus Christi MPO), the region's Metropolitan Planning Organization (MPO), in collaboration with TxDOT and the CCRTA. The Corpus Christi MPO will coordinate with TxDOT and CCRTA to revise the TIP, tentatively scheduled for release for public comment at the April 2, 2020 TPC meeting and adoption by the TPC during the May 7, 2020 meeting.

#### **Prior TPC Actions**

- The FY 2019-2022 Transportation Improvement Program (TIP) was adopted on April 5, 2018.
- Amendment to the 2019-2022 TIP was approved on December 6, 2018.
- Amendment to the 2019-2022 TIP was approved on April 4, 2019.
- Amendment to the 2019-2022 TIP was approved on June 10, 2019.
- Amendment to the 2019-2022 TIP was approved on October 14, 2019.
- Amendment to the 2019-2022 TIP was approved on November 21, 2019.

#### **Financial Impact**

None at this time. In the future the FY 2021-2024 TIP will contain funding estimates by all sources to accomplish the projects and programs identified within the TIP document. Some of these funds are from the TPC member entities.

#### **Background**

Congress requires MPOs and DOTs to invest their federal funds using performance-based planning and performance targets for safety, transit asset management, pavement & bridge conditions, and operational performance of the National Highway System (NHS). This requirement includes providing a baseline and tracking and reporting changes in performance so that the public can see progress toward improving each of the adopted metrics. The adopted goals and performance metrics for the Corpus Christi MPO are found in Chapter 3 of the adopted 2020-2045 Metropolitan Transportation Plan.

Federally funded projects in the TIP must first be included in the Metropolitan Transportation Plan. The MTP is the document which directs transportation investments over a 25-year horizon. A TIP is the implementation of the projects included in the adopted MTP. The production of the TIP is the culmination of the regional transportation planning process and represents a consensus among state and regional officials for which projects are implemented. Consensus is important because the federal and state governments want assurances that all parties have cooperatively developed priorities before committing funds to a project. A project's inclusion in the TIP signifies regional agreement on the priority of the project and establishes federal fund eligibility. Under federal law, the TIP:

- Covers a minimum four-year period.
- Is updated at least every four years, and can be updated sooner, but must be updated in a cycle compatible with the <a href="State Transportation Improvement Plan">State Transportation Improvement Plan</a> (STIP).
- The TIP must be fiscally constrained, by project and by year and is not a "wish list" of projects.
- Is approved by the MPO and the Governor and is incorporated into the STIP without modification.
- Lists all federally funded and regionally significant locally or privately funded projects.
- The estimated project cost for projects may include the entire project, or may stipulate one project phase (i.e. Feasibility, NEPA, Preliminary Engineering, ROW Purchase, Construction Engineering, Operations, Maintenance).
- The TIP may be changed after it is adopted. The approved TIP can be amended to add new projects, delete projects, advance projects into the first year, and accommodate cost and phase of work or scope changes to a project.
- Minor adjustments can be made administratively, but amendments which add, delete, or significantly alter projects from the TIP must go through a public involvement process and be approved by the MPO Transportation Policy Committee.
- The TIP is multimodal, although in addition to the more traditional highway and public transit projects, the TIP may also include bicycle, pedestrian, regional advanced environmental mitigation, stormwater, and freight-related projects and planning studies.

Within this regulatory framework of metropolitan cooperation, the <u>Texas Department of Transportation</u> has lead responsibility for selecting and programming federally funded Interstate, Maintenance, Bridge, National Highway System, Statewide (non-metropolitan) STP, Safety, Enhancement, and certain FTA projects. While Corpus Christi MPO only directly selects projects in a limited number of funding categories, all projects with federal and state funding require both MPO and TxDOT review and concurrence, and transit projects are reviewed for consistency with the MPO MTP. In extreme cases, an

MPO can technically remove transit or DOT-selected federally funded projects from the MTP and TIP within their Metropolitan Planning Area, effectively stopping the project, but the MPO cannot direct how or where most federal funding is spent.

#### **FEDERAL REQUIREMENTS**

#### §450.326 Development and content of the Transportation Improvement Program (TIP).

- (a) The MPO, in cooperation with the State(s) and any affected public transportation operator(s), shall develop a TIP for the metropolitan planning area. The TIP shall reflect the investment priorities established in the current metropolitan transportation plan and shall cover a period of no less than 4 years, be updated at least every 4 years, and be approved by the MPO and the Governor. However, if the TIP covers more than 4 years, the FHWA and the FTA will consider the projects in the additional years as informational. The MPO may update the TIP more frequently, but the cycle for updating the TIP must be compatible with the STIP development and approval process. The TIP expires when the FHWA/FTA approval of the STIP expires. Copies of any updated or revised TIPs must be provided to the FHWA and the FTA.
- **(b)** The MPO shall provide all interested parties with a reasonable opportunity to comment on the proposed TIP as required by §450.316(a). In addition, the MPO shall publish or otherwise make readily available the TIP for public review, including (to the maximum extent practicable) in electronically accessible formats and means, such as the World Wide Web, as described in §450.316(a).
- (c) The TIP shall be designed such that once implemented, it makes progress toward achieving the performance targets established under §450.306(d).
- (d) The TIP shall include, to the maximum extent practicable, a description of the anticipated effect of the TIP toward achieving the performance targets identified in the metropolitan transportation plan, linking investment priorities to those performance targets.
- (e) The TIP shall include capital and non-capital surface transportation projects (or phases of projects) within the boundaries of the metropolitan planning area proposed for funding under 23 U.S.C. and 49 U.S.C. Chapter 53 (including transportation alternatives; associated transit improvements; Federal Lands Access Program projects; HSIP projects; trails projects; accessible pedestrian walkways; and bicycle facilities), except the following that may be included:
  - (1) Safety projects funded under 23 U.S.C. 402 and 49 U.S.C. 31102;
  - (2) Metropolitan planning projects funded under 23 U.S.C. 104(d), and 49 U.S.C. 5305(d);
  - (3) State planning and research projects funded under 23 U.S.C. 505 and 49 U.S.C. 5305(e);
  - (4) At the discretion of the State and MPO, metropolitan planning projects funded with Surface Transportation Program funds;
  - (5) Emergency relief projects (except those involving substantial functional, locational, or capacity changes);
  - (6) National planning and research projects funded under 49 U.S.C. 5314; and
  - (7) Project management oversight projects funded under 49 U.S.C. 5327.
- (f) The TIP shall contain all regionally significant projects requiring an action by the FHWA or the FTA whether or not the projects are funded under title 23 U.S.C. Chapters 1 and 2 or title 49 U.S.C. Chapter 53 (e.g., addition of an interchange to the Interstate System with State, local, and/or private funds and congressionally designated projects not funded under 23 U.S.C. or 49 U.S.C. Chapter 53). For public information and conformity purposes, the TIP shall include all regionally significant projects proposed to be funded with Federal funds other than those administered by the FHWA or the FTA, as well as all regionally significant projects to be funded with non-Federal funds.
- (g) The TIP shall include, for each project or phase (e.g., preliminary engineering, environment/NEPA, right-of-way, design, or construction), the following:
  - (1) Sufficient descriptive material (*i.e.,* type of work, termini, and length) to identify the project or phase;
  - (2) Estimated total project cost, which may extend beyond the 4 years of the TIP;
  - (3) The amount of Federal funds proposed to be obligated during each program year for the project or phase (for the first year, this includes the proposed category of Federal funds and

- source(s) of non-Federal funds. For the second, third, and fourth years, this includes the likely category or possible categories of Federal funds and sources of non-Federal funds);
- (4) Identification of the agencies responsible for carrying out the project or phase;
- (5) In nonattainment and maintenance areas, identification of those projects that are identified as TCMs in the applicable SIP;
- (6) In nonattainment and maintenance areas, included projects shall be specified in sufficient detail (design concept and scope) for air quality analysis in accordance with the EPA transportation conformity regulations (40 CFR part 93, subpart A); and
- (7) In areas with Americans with Disabilities Act required paratransit and key station plans, identification of those projects that will implement these plans.
- (h) Projects that are not appropriate scale for individual identification in a given program year may be grouped by function, work type, and/or geographic area using the applicable classifications under 23 CFR 771.117(c) and (d) and/or 40 CFR part 93. In addition, projects proposed for funding under title 23 U.S.C. Chapter 2 that are not regionally significant may be grouped in one line item or identified individually in the TIP.
- (i) Each project or project phase included in the TIP shall be consistent with the approved metropolitan transportation plan.
- (j) The TIP shall include a financial plan that demonstrates how the approved TIP can be implemented, indicates resources from public and private sources that are reasonably expected to be made available to carry out the TIP, and recommends any additional financing strategies for needed projects and programs. In developing the TIP, the MPO, State(s), and public transportation operator(s) shall cooperatively develop estimates of funds that are reasonably expected to be available to support TIP implementation in accordance with §450.314(a). Only projects for which construction or operating funds can reasonably be expected to be available may be included. In the case of new funding sources, strategies for ensuring their availability shall be identified. In developing the financial plan, the MPO shall take into account all projects and strategies funded under title 23 U.S.C., title 49 U.S.C. Chapter 53, and other Federal funds; and regionally significant projects that are not federally funded. For purposes of transportation operations and maintenance, the financial plan shall contain system-level estimates of costs and revenue sources that are reasonably expected to be available to adequately operate and maintain Federal-aid highways (as defined by 23 U.S.C. 101(a)(6)) and public transportation (as defined by title 49 U.S.C. Chapter 53). In addition, for illustrative purposes, the financial plan may include additional projects that would be included in the TIP if reasonable additional resources beyond those identified in the financial plan were to become available. Revenue and cost estimates for the TIP must use an inflation rate(s) to reflect "year of expenditure dollars," based on reasonable financial principles and information, developed cooperatively by the MPO, State(s), and public transportation operator(s).
- (k) The TIP shall include a project, or a phase of a project, only if full funding can reasonably be anticipated to be available for the project within the time period contemplated for completion of the project. In nonattainment and maintenance areas, projects included in the first 2 years of the TIP shall be limited to those for which funds are available or committed. For the TIP, financial constraint shall be demonstrated and maintained by year and shall include sufficient financial information to demonstrate which projects are to be implemented using current and/or reasonably available revenues, while federally supported facilities are being adequately operated and maintained. In the case of proposed funding sources, strategies for ensuring their availability shall be identified in the financial plan consistent with paragraph (h) of this section. In nonattainment and maintenance areas, the TIP shall give priority to eligible TCMs identified in the approved SIP in accordance with the EPA transportation conformity regulations (40 CFR part 93, subpart A) and shall provide for their timely implementation.
- (I) In cases that the FHWA and the FTA find a TIP to be fiscally constrained and a revenue source is subsequently removed or substantially reduced (*i.e.*, by legislative or administrative actions), the FHWA and the FTA will not withdraw the original determination of fiscal constraint. However, in such cases, the

FHWA and the FTA will not act on an updated or amended TIP that does not reflect the changed revenue situation.

- (m) Procedures or agreements that distribute suballocated Surface Transportation Program funds to individual jurisdictions or modes within the MPA by pre-determined percentages or formulas are inconsistent with the legislative provisions that require the MPO, in cooperation with the State and the public transportation operator, to develop a prioritized and financially constrained TIP and shall not be used unless they can be clearly shown to be based on considerations required to be addressed as part of the metropolitan transportation planning process.
- (n) As a management tool for monitoring progress in implementing the transportation plan, the TIP should:
  - (1) Identify the criteria and process for prioritizing implementation of transportation plan elements (including multimodal trade-offs) for inclusion in the TIP and any changes in priorities from previous TIPs;
  - (2) List major projects from the previous TIP that were implemented and identify any significant delays in the planned implementation of major projects;
- (p) Projects in any of the first 4 years of the TIP may be advanced in place of another project in the first 4 years of the TIP, subject to the project selection requirements of §450.332. In addition, the MPO may revise the TIP at any time under procedures agreed to by the State, MPO, and public transportation operator(s) consistent with the TIP development procedures established in this section, as well as the procedures for the MPO participation plan (see §450.316(a)) and FHWA/FTA actions on the TIP (see §450.330).
