Please be advised that there are two amendments to the current FY2011 – 2014 Transportation Improvement Program (TIP). These amendments were approved by the Transportation Policy Committee on October 8, 2010.

Additional transit projects to the TIP (FY2011):

- JARC-01-08: Northwest Circulator Service – Provide additional circulator service in Northwest area targeting low-income population. This project includes the purchase of a cutaway van with capacity for 3 wheelchair spaces and a heavy duty lift and the operation cost. Total cost is \$457,946.
- NF-01-08: Origin-to-Destination Service for elderly and persons with disabilities – Provide origin-to-destination service for elderly and persons with disabilities. This project includes the purchase of a van-type vehicle with seating capacity for 12 riders, 3 wheelchair spaces, and a heavy duty lift and the operation cost. Total cost is \$290,466.
